

INFORMATION**on a new procedure of admission of foreign citizens to the bachelor degree of the Tashkent State University of Law**

The Tashkent State University of Law is a basic higher educational and scientific-methodical institution of Uzbekistan for formation and retraining of legal personnel on the specialty "jurisprudence". The University is in the heart of a thriving Central Asia, in Tashkent – the center of gravity of the world business elite, where the growth of jobs for legal professionals with an international profile is expected.

The wealth of Tashkent is its cultural diversity and its predominant geographical location at the intersection of the East and the West. The university is located in a historic building in the very center of the capital.

Attracting prospective students is our main goal and we believe that the distance factor should never be an obstacle. To this end, we have created a flexible access program for all those who are interested in obtaining a high-quality higher legal education.

The admission of foreign citizens to the bachelor degree of the Tashkent State University of Law (hereinafter referred to as the TSUL), starting from 2017/2018 academic year, unlike citizens of the Republic of Uzbekistan, will be undertaken in a simplified manner, without conducting tests and only according to the results of the interview.

The international prestige of the university is evidenced by our international relations and student exchange projects with Boston College of Law School, the University of Toulouse 1 Capitole, Nagoya University, Osaka University, Northwest University of Politics and Law (China), East China University of Political Science and Law.

Flexible curriculum and professional teaching staff with high scientific competence create unlimited opportunities for self-realization of students.

Regardless of what your academic or professional goals may be, participating in extracurricular activities of the *tsul-art*, a theater-studio can be an important part of your experience, creating unique opportunities for friendship and talent development.

The electronic form of application for admission is filled in real time and is accepted until Saturday July 15, 2017. It is necessary to attach the relevant documents in electronic form to an electronic application on admission.

If all necessary documents are submitted in accordance with the requirements within 72 hours, the application is registered by assigning a unique number to it and the Applicant is informed that it is necessary to present the original documents 3 days before the interview.

In case of non-compliance of the submitted documents with the established requirements, a notification on non-compliance will be sent to the indicated e-mail address in the application within 72 hours.

The number of registered applications for admission is posted on daily basis on the web site of the TSUL.

In order to be eligible for the admission to the bachelor's program of the TSUL, foreign students should master the languages of education at the Tashkent State University of Law – Uzbek and Russian.

An interview on professional inclinations and motivations of the Applicant is held between Wednesday, August 2nd, 2017 and Thursday, August 10th 2017.

Prior to the interview, consultations are organized; the timetable of the latter is available on the web site of the TSUL.

The applicant is considered not eligible for admission in the following cases:
non-attendance of the applicant for the interview according to the schedule (The applicant gets a score of 0 point);
the applicant gets 55 percent or less of the established maximum score (100 points) for the interview.
